STUDENT DRIVER RULES AND REGULATIONS

Driving to school and park in a secure parking lot is a privilege at Dover Area High School. Students who park at the DAHS Student Parking lot must have a parking permit hanging from the rear-view mirror and visible from the front of the car. A permit is going for the entire school year. Student drivers must abide by the following rules and regulations in order to maintain parking privileges.

A student may have his or her permit suspended or permanently revoked if he or she fails to obey Student Driver Rules and Regulations.

- 1. Students parking at DAHS Student parking lot must have a parking permit (cost is \$20 and it is non-refundable). Lost tags will be replaced for a fee of \$5.
- 2. Students without a parking permit hanging in their car will following the guidelines below:
 - a. 1st time- Verbal Warning issued
 - b. 2nd time- Phone call home
 - c. 3rd time- parking privilege revoked and trespassing will be issued.
- 3. **The maximum speed limit on school property is 10 miles per hour.** Any student who drives recklessly on school property or who possesses/uses another student's parking permit will be subject to school disciplinary action and/or loss of parking privileges.
- 4. **Good Attendance and Good behavioral conduct** are required to continue with the parking privilege. Students may park in any lined space in the student parking lot ONLY. Students may not visit their vehicles during the school day without approval from the Building Principal or Assistant Principals.
- 5. Vehicles operated by students are prohibited from driving through or around buses that are discharging or picking up students.
- 6. Parking on school property is done at the driver's own risk. DAHS is not responsible for any damage or vandalism that may occur to a student vehicle, nor is it responsible for any theft from vehicles.
- 7. It is the responsibility of the student to inform the main office of any changes in the application form. If a student driver will be using a vehicle besides the one registered, it is the driver's responsibility to notify the office.
- 8. Given reasonable suspicion of misconduct as defined in the Student Handbook, student vehicles may be subject to search by school or police personnel. Search and seizure procedures may be assisted with the use of certified scent dogs under the authority of the Northern York Regional Police Department. Objects, materials, or substances recovered in a search of a student vehicle may be used as evidence against students in disciplinary, juvenile, or criminal proceedings.
- 9. Parking on school property is a privilege that can be revoked for violation of applicable school rules or local laws. Permits may be suspended or revoked without refund following ISS/OSS at the administrator's discretion.
